USHJA ZONE HOTY CHAMPIONSHIP

A USHJA Zone Horse of the Year Championship is designed to reward participants in the USHJA Zone Horse of the Year Award Program by providing them with the opportunity to earn Championship Points.

- USHJA Zone HOTY Championships are held based upon the recommendation of the applicable Zone Committee and Working Group, and subject to the approval of the Executive Director.
- USHJA Zone Horse of the Year Championships are open to competitors who meet the minimum eligibility requirements, unless a
 zone specifically creates qualifying criteria and provides it to USHJA.
- In order to earn Championship Points in Hunter and Jumper sections, the owner or recorded leasee of the horse/pony must reside
 within the Zone. Horse owner, rider and trainer must be Active/competing members of USEF and USHJA. Horses must have a USEF
 annual or Life recording and USHJA registration. In Equitation sections the rider must reside within the Zone to participate in the
 HOTY Championship and receive Championship Points.
- If a section held at a USHJA Zone Horse of the Year Championship is open to all competitors, then the Competition Management is responsible for placing the class a second time including only those who are Zone members. The second set of results must be submitted to USEF.
- Each USHJA Zone Horse of the Year Championship must offer a minimum of 50% of the applicable Zone Horse of the Year Awards sections.
 - Hunter and Equitation Section Format: must be offered with a minimum of two over fences classes and one under saddle class as defined in HU148. If offered in the section format, then Management may designate classes of an existing section that will count for the USHJA Zone Championship Points. Additional classes are not required to be held for the USHJA Zone HOTY Championships. Eligible exhibitors that place 1st-8th in each class will receive Zone HOTY Championship Points. Zone HOTY Championship Points will be awarded for Champion and Reserve Champion.
 - Hunter Classic Format: may also be offered in a Classic format with two over fences rounds. If offered in this format then
 eligible exhibitors that place 1st-8th in the second round of the Hunter Classic will receive Zone HOTY Championship Points.
 - Jumper Section Format: may be offered as two or three individual classes. If offered in this format then Management may designate classes of an existing section that will count for the USHJA Zone Championship Points. Additional classes are not required to be held for the USHJA Zone HOTY Championships. Eligible exhibitors that place 1st-8th in each class will receive Zone HOTY Championship Points.
 - Jumper Classic Format: may also be offered in a two round/one jump-off Classic format. If offered in this format, eligible
 exhibitors who that place 1st-8th for the championship overall placings in the Classic will receive Zone HOTY Championship
 Points.
- A minimum of 3 Zone HOTY Championship exhibitors must compete in order for the Zone HOTY Championship Points to be awarded. The definition of compete for Hunters and Age Group Equitation is in accordance with HU133 and the definition of compete for Jumpers is in accordance with JP135.13.

 If the competition charges exhibitors an extra fee ("Armband Fees") to compete in the Zone HOTY Championship, a minimum of 3 Zone HOTY Championship exhibitors must pay the additional fee and compete in order for Zone HOTY Championship Points to be awarded.

Champion and Reserve Championship Points will be given to the Zone HOTY Championships sections that follow HU148. Champions will receive 80 Championship Points for each section completed and Reserve Champions will receive 48 Championship Points.

JUMPERS

Low Children's/Adult Amateur Jumpers, High Children's/Adult Amateur Jumpers and Thoroughbred Jumper will receive points from the Zone HOTY Championship Point Chart excluding Champion and Reserve points. 1.20/1.25 Junior Jumper, 1.20/1.25 Amateur Owner Jumper, 1.30/1.35 Junior Jumper, 1.30/1.35 Amateur Owner Jumper, 1.40/1.45 Junior Jumper, 1.40/1.45 Amateur Owner Jumper, Pony Jumpers and Young Jumpers will be based on one point for every dollar won unless no money is awarded and then these classes will receive the points from the Zone HOTY Championship Point Chart excluding Champion and Reserve points.

Champion and Reserve Championship Points will be given to the Zone HOTY Championships sections that follow HU148. Champions will receive 80 Championship Points for each section completed and Reserve Champions will receive 48 Championship Points.

Rules & Regulations

• Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted in accordance therewith.

• Should any question or dispute arise which is not provided for in the rules, the decision of show management and the show committee will be final.

• The second trip of each section will be judged under the open numerical system with scores announced.

· Junior and Amateur Owner Hunters will be jogged for soundness in all over fences classes.

• **QUALIFYING**: Entries for the Zone 2 Hunter Championship will be limited based on USHJA Zone 2 points earned by horses/ponies at no more than 15 shows starting on or after September 1, 2016 through shows starting on or before August 31, 2017. No rider may ride more than two entries in any section. Management will allow the horses/ponies who were Champions in 2016 to show in their respective sections, if entered by the close of entries and eligible. Point totals will be verified with USHJA.

• Entries must have earned at least one point in their section to be eligible for the Zone 2 Hunter Championship. Horse and rider must be recorded in Zone 2 and points count only from Zone 2.

• ACCEPTANCE: Qualifying lists will be posted at www.ryegate.com. Acceptance letters will be sent no later than September 18th. Preferred method will be via email and fax. Hard copy will only be sent if no other method is available. Letters will be sent by annettel@ryegate.com, please make sure to add this as a safe sender to your email.

• **ELIGIBLITY**: Riders in all sections may only show in the Pessoa/USEF Medal Finals (and associated training session) and the NAL Finals and still participate in the Zone 2 Hunter Championship. Horses in all sections may only show in the Pessoa/USEF Medal Finals (and associated training session) and the NAL Finals and still participate in the Zone 2 Hunter Championship.

You may enter both shows, but must comply with any cross entry restrictions at the time of the show. • **CLOSING DATE**: Entries must be postmarked before midnight EDT on September 1, 2017. Should an entry bear both a postage meter date and postmark by the Post Office Department, the Post Office date will be considered the effective date of mailing. Should an entry bear a postage meter date and no Post Office Department postmark, the metered date shall be valid only if received within seven days of the date shown. Entries sent via courier service must be entered into the courier's system by the courier's representative before midnight on the date shown above to be considered on time. A date and/or time entered on the waybill by the sender is not considered the official date/time of sending. Dropping the entries into a courier pickup box does not constitute "postmark" until entered into the courier's system by their representative.

• WAIT LIST & LATE ENTRIES: A wait list of on time entries will be established in order of points. Should there be declines from the accepted entries, the Zone 2 Hunter Championship will proceed down the wait list in order. If the qualifying lists are exhausted and spaces are still available in accordance with entry quotas, the Zone 2 Hunter Championship reserves the right to accept late entries in the order of postmark for all sections.

• **QUALIFYING & ENTRY FEE**: A non-refundable qualifying fee of \$40 will be charged to each entry. A fee of \$305 will be charged for each horse accepted which includes one (1) stall, entry fee, USEF Fee, D&M Fee and Zone Fee. Full payment of accepted horses is due by October 1st. Make checks payable to USHJA.

• **STALLS**: All stalls are temporary, vinyl, approximately 10x10, with doors, housed in permanent buildings. One stall is included in the entry fee. Tack/grooming stalls are available at \$100 per stall. Stalls will be available from 5:00 p.m. Saturday and must be vacated by midnight Sunday. Anyone needing to deviate from this must contact the show in advance.

• **RETURNED CHECKS**: There will be a \$50 charge for any returned check.

• **ARRIVAL**: Upon arrival, exhibitors must check in with the Stabling Office and the Zone 2 Horse Show Office. Exhibitors must use stalls assigned for Zone 2 by the stable manager. Use of unauthorized stalls will incur an additional charge.

Rules & Regulations Continued

• **REFUNDS/SCRATCH FEE**: Full payment for accepted horses is due by October 1st. Declines or scratches received by October 1st will receive a full refund of entry fee. Office/qualifying fee is non-refundable. Scratches received after October 1st, but before October 15th, will receive a refund less a \$35 scratch fee if accompanied by a signed licensed veterinarian scratch. The remaining entry fee will be refunded within thirty (30) days of the conclusion of the Zone 2 Hunter Championship. No refunds will be issued for scratches received on or after October 15th for any reason.

• SCHOOLING: Exhibitors must wear their number while in the ring, including during schooling. Riding will be permitted in the main arena the morning of the competition, for FLAT WORK only. See Schooling Schedule for times. No Jumping will be permitted. No horse or pony in the Zone 2 Hunter Championship may be ridden anywhere on the show grounds prior to the conclusion of the Pennsylvania National Horse Show, and may not be ridden in the arena prior to Sunday morning's designated times. Any horse or pony found in violation will be eliminated from the competition. Horses and/or riders competing in approved classes at the Pennsylvania National Horse Show may school in preparation for those classes in accordance with the rules of PNHS, but following the conclusion of the class these horses must not be ridden on the grounds until Sunday morning and must comply with all other rules and regulations as they apply to all Zone 2 Hunter Championship entries.

• **RIBBONS:** Eight ribbons will be awarded in all performance classes.

• **DOGS**: Dogs are not permitted on the premises unless restrained on a leash. NO DOGS ARE PERMITTED IN THE SEATING AREAS OR THE HORSE SHOW OFFICE.

• **CREDENTIALS**: Every owner, trainer and rider must present proof of current USEF and USHJA membership and horse recording. All children's ponies and junior hunters must present proof of a current USEF Measurement card.

• HEALTH REQUIREMENTS: A Negative Coggins Test dated within one year is required for each entry. All horses on the grounds must comply with and provide proof of vaccinations per USEF GR845. Any additional Health Requirements will be sent with acceptance letters. To expedite processing upon your arrival at the show, please send a copy with your entry blank or acknowledgment. NO NUMBERS WILL BE RELEASED FROM OFFICE WITHOUT COGGINS OR VACCINATION PROOF.

Follow I-78 toward Harrisburg. Exit I-81 South onto Cameron Street and follow signs to Farm Show Complex. Approx. 195 miles from Great Neck, NY.

New York, NY: Holland Tunnel to 14th Street becomes US-1 and 9/US-9S/US-1S. Take I-78 West express toward Garden State Parkway. Merge onto I-81S. Exit I-81 South onto Cameron Street and follow signs to Farm Show Complex. Approx. 170 miles.

Philadelphia, **PA:** West on I-76 toward Valley Forge. Merge onto I-283N via Exit 257 toward Harrisburg/Hershey. I-283 N becomes I-83N/US-322W. Merge onto I-81S. Exit I-81 South onto Cameron Street and follow signs to Farm Show Complex. Approx. 110 miles.

Scranton, PA: Follow I-81S to Cameron Street Exit and follow signs to Farm Show Complex.



In accordance with GR1301.7: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals with disabilities are exempt from this rule.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions, Reining Competitions and Combined Driving Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

FEDERATION ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.
